Heart House

Heart House is a six room shelter for women and children who need to flee a domestic abuse and/or homeless crisis situation.

In 2017 we had 22 women and 21 children enter our shelter doors.

The average age of the women was 35 year old.

77% of our shelter guests were from a homeless situations.

2082 Nights In Shelter

A resident of the shelter works together with the Heart House case manager to set attainable goals to live an independent and healthy life.

Three critical components — mental, emotional, and spiritual - are examined and an individualized program is established for immediate and long-term needs.

The individualized program directives change throughout the progression through the program.

These directives are steps and goals to achieve selfreliance, self-confidence, self-worth, and the ability to successfully leave the shelter with the tools to live independently.



Heartline

Heartline is an agency that can assist with rent, utilities, food, diapers/ formula, clothing, household or hygiene products, prescription drug, and gas or transportation. Heartline is not an agency that simply distributes funds on whim. Rather, the Program Manager works one on one with each client to get to the root of the situation that brought clients to this crisis point to determine if funds will be distributed. Typically, an action plan is requested as to how to prevent future crises.

** Heartline is not a handout but a hand up **

Heartline served 1248 clients and gave 161 referrals to other outside agencies or organizations best suited to help in that given crisis.

Heartline also offers several monthly education classes in our Community Room, free and open to the public. On average, 15 -16 people attend classes each month. Attendees are able to receive household supplies not supplied by the local food pantry. In 2017, 264 bags of paper products and 119 packages of diapers were distributed.

Programs specifically supported by Heartline include Operation Backpack (237 children received grade appropriate school supplies) and Tree of Hearts (326 children received Christmas gifts and over 200 families received Christmas food boxes).

Our Volunteers are Super Heroes!

We have over 200 faithful volunteers who regularly answer phones, bake, shop, sort, organize, wrap, distribute, do dishes, deliver, cheer, take pictures, teach, cook, serve, ring bells, drive, write, babysit, paint, repair, and dedicate time, resources and energy to our organization!



super Hero volunteer (noun): A benevolent person who is always willing to lend a hand on a continued basis throughout the season. A person who takes on extra duties above and beyond their role description or an event volunteer who is generous with their time and energy.


Benevolence Partners

8 Area churches gave \$26,245 00 to the Benevolence Fund

52 families received assistance with utilities bills (electric, water)

19 clients were assisted with security deposits, 35 families received rental assistance and one was helped with a mortgage payment.

In 2017, LIHEAP program was funded only through June, and Illinois brought back the PIPP program, but despite these state programs Heartline clients saw an increase need in electric bills. While Woodford County housing program is strong, there are still clients who find it hard to pay the reduced costs of housing assistance. HUD does not assist with security deposits. The continued partnership of area churches in supporting the Benevolence Program is crucial, especially with




